A RESOLUTION AUTHORIZING THE CITY OF HIGHLAND PARK TO ACCEPT FUNDING ASSISTANCE FROM WAYNE METROPOLITAN ACTION AGENCY IN CONJUNCTION WITH THE DEPARTMENT OF ENVIRONMENT, GREAT LAKES, AND ENERGY (EGLE) WATER RESTART GRANT PROGRAM AS PART OF EO 2020-28 REQUIRING MUNICIPALITIES TO RESTORE WATER SERVICE TO RESIDENCES DURING THE COVID-19 PANDEMIC

WHEREAS, on March 10, 2020, the Michigan Department of Health and Human Services identified the first two presumptive-positive cases of COVID-19 in the State of Michigan. Consequently, Governor Whitmer issued Executive Order 2020-4; and

WHEREAS, Executive Order 2020-4 declared a state of emergency across the State of Michigan under section 1 of article 5 of the Michigan Constitution of 1963, the Emergency Management Act, 1976 PA 390, as amended, MCL 30.401-.421, and the Emergency Powers of the Governor Act of 1945, 1945 PA 302, as amended, MCL 10.31-.33; and

WHEREAS, Wayne Metropolitan Action Agency has agreed to assist the City of Highland Park with financial assistance on the local match requirement set forth in the terms of the ReStart Grant Program for an amount not to exceed \$125,000 as identified in the letter to the Water Department Director, dated June 8, 2020; and

WHEREAS, Wayne Metropolitan Action Agency agrees, if funding remains after restoring water to customers in Highland Park, Wayne Metropolitan Action Agency agrees to work closely with the City of Highland Park for the purpose of providing additional financial assistance to those customers who have been impacted financially and qualify for assistance; and

BE IT RESOLVED, the Highland Park City Council APPROVES the City of Highland Park to accept financial assistance from Wayne Metropolitan Action Agency for the local match requirement set forth in the terms of the ReStart Grant Program. Yeas (5), Nays (0), Absent (0).
