This was a very brief meeting of the Historic District Commission due to the Oral History Training Workshop the commission was hosting at 6:00PM (directly after the meeting).

REPORT FROM COMMUNITY & ECONOMIC DEVELOPMENT (CED) DIRECTOR -5:35PM

Alan Higgins, the HDC's contact with the Michigan SHPO office, will be dropping by in either June or July when there's a conference in Detroit to meet the commission in person and see how we're doing.

Chair Zobel let the commission know that she had spoken with Ruth Harlin, who owns a historic home on Moss Street. Ruth is working with the family of the original owners to have her home recognized as history by the state of Michigan by having it added to the historic places registry (it is already recognized as history by the federal government, and not recognized as historic locally). Chair Zobel will update the commission if further information related to Ruth's addition to the state registry is received.
