WHEREAS, the City of Highland Park wishes to adopt a local Ordinance adopting Public Act No. 230, of the Acts of 1972, (MCL 125.1501 et seq.).

WHEREAS, the Charter for the City of Highland Park provides that Council has the authority to enact all ordinances they deem necessary for the safety, order, and good government of the City and the general welfare of the inhabitants

NOW, THEREFORE, THE CITY OF HIGHLAND PARK ORDAINS:

CONSTRUCTION CODES: PART 1420

Pursuant to the provisions of the State Building Code, in accordance with Public Act No. 230, of the Acts of 1972, (MCL 125.1501 et seq.) the City of Highland Park hereby assumes the responsibility for the administration and enforcement of that act and code throughout its corporate limits. ELECTRICAL CODE PART: 1428

Pursuant to the provisions of the State Electrical Code, in accordance with Public Act No. 230, of the Acts of 1972, (MCL 125.1501 et seq.) the City of Highland Park hereby assumes the responsibility for the administration and enforcement of that act and code throughout its corporate limits. The building official of the City of Highland Park is designated as the enforcing agency to discharge the responsibilities of the city under the Act.

An Ordinance to amend the Highland Park City Property Maintenance Code, Chapter 1426 by repealing the 2009 International Property Maintenance code to adopt the 2015 International Property Maintenance Code as promulgated, published and approved by the International Code Council, Inc., and to provide a means for the city to promote, protect and safeguard the public health, safety and welfare of its citizens.

WHEREAS, the City of Highland Park wishes to amend a local Ordinance adopting the 2015 International Property Maintenance Code.

WHEREAS, the Charter for the City of Highland Park provides that Council has the authority to enact all ordinances they deem necessary for the safety, order, and good government of the City and the general welfare of the inhabitants

NOW, THEREFORE, THE CITY OF HIGHLAND PARK ORDAINS:

<u>SECTION 1.</u> The existing Chapter 1426 of the Highland Park Code of Ordinances is hereby repealed and the following new Section 1426.010 is hereby adopted to stand in its place.

"§1426.010 ADOPTION AND INCORPORATION OF THE 2015 INTERNATIONAL PROPERTY MAINTENANCE CODE.

There is hereby adopted by reference the 2015 International Property Maintenance Code, as promulgated, published and approved by the International Code Council, Inc., together with all amendments, references and supplements herein is hereby adopted as the Property Maintenance Code of the City of Highland Park; provided, that any provisions thereof are not in conflict of any provisions of this Code of Ordinances. The Building Official is designated as the enforcing agent to discharge the responsibilities and enforce the provisions of this code."

<u>SECTION 2.</u> The existing Chapter 1426 of the Highland Park Code of Ordinances are hereby repealed and the following new Section 1426.011 is hereby adopted to stand in its place.

§1426.011 ADDITIONS; INSERTIONS; AMENDMENTS.

- (1) Section 101.1 Title. Insert: "the City of Highland Park"
- (2) Section 103.5 Fees. Insert: "In accordance with the fee schedule established by resolution of the City Council."
