# 30<sup>th</sup> DISTRICT COURT 01-21-20 V

The following resolution was submitted for approval.

WHEREAS, the State of Michigan, created the mental health court statute in December 2013. The statute provides authority for the trial courts to develop and operate mental health courts statewide. Specifically, MCL 600.1090(e)(ii) guides courts in program implementation by adhering to the *Essential Elements of a Mental Health Court*,

WHEREAS, the 30<sup>th</sup> District Court for the City of Highland Park applied to the Michigan Supreme Court through its administrative office for grants funds in order to implement a mental health docket, called "Mentally There" at the 30 District Court,

WHEREAS, there is a need to offer a program that could give intensive services to those with mental health issues, as the 30<sup>th</sup> District Court is presently servicing approximately 120 non-violent misdemeanants of which approximately 20% have been diagnosed with a mental health illness, serious emotional disturbance or a developmental disability.

WHEREAS, the 30<sup>th</sup> District Court has received notification from the Michigan Supreme Court, State Court Administrative Office, advising of its intent to reimburse the amount of \$37,307.00, in order to fund implementation of the "Mentally There" docket at the 30<sup>th</sup> District Court for the 2019-2020 fiscal year, and

WHEREAS, the City and the Court recognizes the increase of those with a diagnosed mental illness entering the criminal justice system, along with the need to offer these intensive services in our community to assist with recidivism, lessen our jail population, decrease negative police contact and protect the community,

BE IT FINALLY RESOLVED, that the Highland Park City Council hereby authorizes the appropriate City officials to do all things necessary to accept the award of Michigan Supreme Court, State Court Administrative Office, Grant #18236, for fiscal year 2020, in the amount of \$37,307.00 as well as any subsequent fiscal years that these funds remain available from the grantor. # RESOLUTION TO AMEND CONTRACT AND APPROVE PAYMENT TO HOME TEAM AN ADDITIONAL AMOUNT OF \$53,475.00

Moved by Council Pro Tem Patrick Supported by Councilmember Bates

**WHEREAS,** on October 2, 2018, the City of Highland Park entered into a Contractor Agreement with Home Team Highland Park, LLC, for the renovation and sale of the following properties located in and owned by the City of Highland Park: 116-118 Pilgrim, 170 Moss, 200 Puritan, and 153 Eason; and

**WHEREAS**, the terms and conditions of the Contractor Agreement, which was approved by Council on November 19, 2018, were pursuant to the NSP Request for Proposals for Single- Family Development/Repair; and

**WHEREAS**, the amount of the original bid was \$117,616.25 for the renovation of all four properties, which amount was paid to Home Team in March of 2019; and

**WHEREAS**, additional renovations beyond the original scope were discovered to properly renovate the properties and make them marketable for sale, which amounts to an additional cost of \$53,475.00; and

**WHEREAS,** the City of Highland Park currently needs to be but is not in good standing with the Michigan State Housing Development Authority (MSHDA) due to its noncompliance with NSP related to the properties that remain unsold; and

**WHEREAS**, the sale of these properties is imperative, not only for the ongoing development of the City of Highland Park, but to avoid continued noncompliance with NSP provisions; and;

**WHEREAS**, the sale of the properties will generate enough to offset the additional monies requested by Home Team without accessing additional City funds, and;

WHEREAS, the payment would require an amendment to the existing contract to allow for

this change.

**NOW, THEREFORE, BE IT RESOLVED,** that City Council approves amendment of the contract and payment to Home Team an additional amount of \$53,475.00 for performing additional, unforeseen renovations, to be taken from the \$110,000 sale of 153 Eason. # RESOLUTION TO ADOPT POVERTY EXEMPTION GUIDELINES FOR HIGHLAND PARK BOARD OF REVIEW

Moved by Councilmember Bates Supported by Council Pro Tem Patrick

**Whereas,** the homestead of persons who, in the judgment of the Board of Review, by reason of poverty, are unable to contribute to the public charges, is eligible for exemption in whole or part from taxation under MCL 311.7u; and

**Whereas,** one of the provisions of PA 620 of 2002 is that local governing bodies are required to set income levels for their poverty exemption guideline and those levels SHALL NOT BE SET LOWER by a city than the federal poverty guidelines updated annually by the U.S. Department of Health and Human Services; and

**NOW THEREFORE,** pursuant to MCL 211.7u, the City of Highland Park, Wayne County adopts the following guidelines for the City of Highland Park Board of Review to implement.

To be eligible for a poverty exemption a person shall annually:

- 1. Own and occupy the property as a homestead as required by law.
- 2. File the approved form provided by the City of Highland Park.
- 3. Provide evidence of ownership.
- 4. Submit copies of federal and state income tax returns for all <u>persons</u> residing in the homestead as well as copies of any property tax credit returns, as required by law.
- 5. The Board of Review may require proof of identification it feels it is necessary.

- 6. The household income (including all persons residing in the homestead) shall meet the federal poverty income standards as defined and determined annually by the United States Office of Management and Budget. In cases where household income of a property as herein defined exceeds \$10,000, but meets the federal standard, the assessment shall be adjusted so the out-of-pocket property tax, as best estimated based on the previous year's millage rate and after deducting the applicable state property tax refund, equals five percent (5%) of the household income. In cases where the household income meets the federal standard but is less than \$10,000, the assessment shall be adjusted so the out-of-pocket property tax, as best estimated based on previous year's millage rate and after deducting applicable state property tax refunds, equal three and a half percent (3.5%) of the household income.
- 7. Income included as household income shall be from any and all sources and shall include all dependents' and occupants' income including, but not limited to, types such as salary, state or federal aid, alimony, social security, pension and insurance benefits, return on investments and savings and any other forms of compensation received.
- 8. The total of all liquid assets, not including the homestead, shall not exceed \$5,000.
- 9. The Board of Review may waive the income limits for household with greater incomes but who have expenses beyond the ordinary scope of expected costs which are severe and unavoidable, such as unusually high health care costs not covered by insurance. In such catastrophic scenarios, the state equalized value may be reduced to zero (0).
- 10. In cases where the Board of Review deviates from the income limits for substantial and compelling reasons, such as described above in number 9, these reasons will be noted on the petition and communicated in writing to the claimant. Such reason will be properly documented.
- 11. In no case will the Board of Review approve an assessment reduction without the necessary and required documentation.
- 12. In the case of a poverty appeal, a copy of the petition and supporting documentation will be kept in a separate file and provided on request to any interested member of the public

**BEIT FURTHER RESOLVED THAT,** the federal poverty household income guidelines stated in Item #6 above and adopted by the City of Highland Park Council Members for use by the City of Highland Park Board of Review for assessment in 2020 and years going forward shall be the federal poverty income standards as defined and determined by the United States Office of Management and Budget, as it may change from year to year, and be published annually by the Michigan State Tax Commission. # RESOLUTION TO WAIVE PENALTIES FOR FAILURE TO FILE PROPERTY TRANSFER AFFIDAVITS

Moved by Councilmember Bates Supported by Council Pro Tem Patrick Whereas, the City of Highland Park is aware that Michigan statue, MCL 211.27 a(LO) requires the buyer, grantee or other transferee of a property to notify the appropriate assessing office within 45 days when a transfer of ownership occurs, and

Whereas, MCL 211.27a(10) further requires that such notification be made on a form prescribed by the State Tax Commission, commonly known as a Property Transfer Affidavit (form 2766 or L-4260), and

Whereas, the City if aware that MCL 211.27b(l)(c) and (d) provides for specific penalties to be levied if the appropriate assessing office is not notified within 45 days, and

Whereas, MCL 211.27b(5) allows the governing body to waive, by resolution, the penalty levied under subsection (l)(c) or (d), and

Whereas, the City of Highland Park Assessing Office has procedures in place to notify the buyer, grantee or transferee of a property when the Property Transfer Affidavit has not been filed, and

Whereas, the City of Highland Park has determined the cost to administer and collect the penalty, then share collected penal tics with other taxing jurisdictions outweighs the benefit, and

**Whereas,** the City finds the collection of penalties is unnecessary.

**Now Therefore Be It Resolved** the Council Members of the City of Highland Park, as provided in MCL 21 1.27b(5), waives the collection of penalties under subsections (l)(c) or (d), and

**Also Therefore Be** It **Resolved** that any resolution, policy or directive in conflict with this Resolution is hereby repealed. Yeas (4), Nays (0), Absent (1) Councilmember Lewis.

WHEREAS, it is necessary for the City of Highland Park Water Department to address water main improvements identified in the 2016 MDEQ (EGLE) Violations Notice and Administrative Consent Order; and

WHEREAS, the City of Highland Park previously received a Significant Deficiency Violation Notice from EGLE on April 11, 2016 regarding the existing water infrastructure; and

WHEREAS, the City of Highland Park previously received a Lead and Copper Monitoring – Action Level (AL) Exceedance letter from EGLE on July 12, 2019 regarding the community water supply's 90th percentile value exceeding the action level for lead during the most recent round of lead and copper monitoring between June and September 2019; and

WHEREAS, as a result of exceeding the lead Action Level (AL) the City of Highland Park is required under the administrative rules promulgated under the Michigan Safe Drinking Water Act, 1976 PA 399, as amended (Act 399) to meet additional requirements including water quality parameter monitoring, source water monitoring, corrosion control treatment, and public education, as well as being mandated to replace a higher percentage of lead service lines; and

WHEREAS, the City Council has reviewed and approved the FY2020 DWRF Project Plan Application as submitted to EGLE; and

WHEREAS, it is the intent of the Water Department Director that when funds are awarded by the State of Michigan Department of Treasury to begin construction in the Spring of 2020; and

BE IT RESOLVED, the City of Highland Park City Water Department requests to publicly advertise the 2020 Water Main and Lead Line Replacement project for purposes of soliciting construction bids, on Wednesday, January 29<sup>th</sup>, 2020. Yeas (4), Nays (0), Absent (1) Councilmember Lewis.
