WHEREAS, the City of Highland Park applied to the Michigan Indigent Defense Commission for grant funds in order to implement the State mandated requirements, and

WHERAS, the City has received notification from the Michigan Indigent Defense Commission advising of its intent to award the amount of 82,727.90 in order to fund implementation, and

WHEREAS, the City has a local match requirement of \$13,500.00 available in the approved 2018-2019 budget appropriated for operation of the 30th District Court, and now therefore,

BE IT FINALLY RESOLVED, that the Highland Park City Council hereby authorizes the appropriate City officials to do all things necessary to accept the award of Michigan Indigent Defense Commission Grant#2019-93 in the amount of \$82,727,90 to comply with the grant agreement/guidelines, and to budget the appropriate revenue and expenditure accounts in Fund 60 (Indigent Defense Fund) for the 2018-19 budget year as well as any subsequent fiscal years that these funds remain available from the grantor. PARKING LOT LIGHTS MAINTENANCE AT DHHS 13233 HAMILTON

WHEREAS, the Sublease and Addendum #1 to the Sublease between the City of Highland Park ("Lessor") and the Department of Technology, Management & Budget ("Lessee") for 13233 Hamilton Avenue, Highland Park, Michigan being used by the Department of Health and Human Services ("DHHS"), provides the following on Notification and Lessor Obligations; and

WHEREAS, Article III, Paragraph 3.1 (s) states that "The Lessor shall keep the Leased premises in good repair, and able to perform and operate as designed free from dangerous or defective conditions, and in tenantable condition, and at the Lessor's sole expense, property and in a manner customarily accepted by the skilled trades, make all repairs and/or replacements, structural or nonstructural of whatever nature", and

WHEREAS. The City was notified by Brian Garden, Program Manager, Department of Health and Human Services, that no lights in the parking lot were functioning, resulting in an unsafe condition for DHHS employees; and

WHEREAS, due to high dollar value we solicited a quote from Allied, which is our Council approved maintenance contractor, and two other vendors (see attached); and

BE IT RESOLVED by The City Council of the City of Highland that DPW be allowed to enter into a contract with Interactive Energies Group for \$13,174.44. Yeas (5), Nays (0), Absent (0).

RESOLUTION TO PAY INVOICES FOR LIGHTING MAINTENANCE/UPGRADES

WHEREAS, the office trailer in the Highland Park yard was dilapidated and unsafe and the yard itself had inadequate lighting to ensure the safety of police and fire as they refuel their vehicles during off hours; and

WHEREAS, the trailer company wanted to remove the existing trailer from their inventory so they replaced it with a newer at no additional rental cost to the City; and

WHEREAS, the Court required updating of all low-voltage wiring for internet and phones in offices and old cubicle areas; and

WHEREAS, Interactive Energies Group replaced and upgraded burned out lighting in the yard and installed lighting on the new office trailer and upgraded wiring in the Court at a cost of \$14,747.14; and

WHEREAS, he quoted amount is available in the Department of Public Works budget and in the Court budget;

RESOLUTION TO ACCEPT QUOTE FOR DOOR REPLACEMENTS

WHEREAS, as part of an ongoing effort to enhance safety measures and upgrade the City's infrastructure, the City of Highland Park Department of Public Works quoted door replacements for the police station and City Hall boiler room exterior doors that are rotted out; and

WHEREAS, Jan Door, a company that specializes in installing such doors, has quoted a price of \$2,295 for the police station door and \$2,495 for the boiler room door for a total of \$4,790 and

WHEREAS, the quoted amount is available in the Department of Public Works budget; and

NOW, THEREFORE, BE IT RESOLVED that the City Council approves the quote of \$4,790 to replace the two doors. Yeas (5), Nays (0), Absent (0).

RESOLUTION APPROVING Labelle TOWERS FOR TAX EXEMPTION UNDER MCL 211.7d

WHEREAS, under MCL.211.7d (1), the Housing Exemption for Elderly and Disabled Families "housing owned and operated by a nonprofit corporation or association, by a limited dividend housing corporation, or by this state, a political subdivision of this state, or an instrumentality of this state, for occupancy or use solely by elderly or disabled families is exempt from the collection of taxes; and

WHEREAS, LaBelle Towers is currently owned by the LaBelle Tower Limited Dividend Housing Association, LP and is a member of the Senior Citizens Cooperative Housing Tax Exemption Program; and

WHEREAS, in accordance with the requirements of MCL 211.7d the owner has filed a Request for New Senior Citizens and/or Disabled Housing Tax Exemption with the City of Highland Park's City Assessor to continue the exemption;

NOW, THEREFORE, BE IT RESOLVED, that the City Council approves LaBelle Tower's claim for exemption pursuant to the statute referenced above. Yeas (5), Nays (0), Absent (0).
