GRANT PROGRAM FROM THE STATE OF MICHIGAN

RESOLUTION TO SOLICIT BIDS FOR ASPHALT FOR POTHOLE REPAIR

WHEREAS, potholes are a common nuisance in all of Michigan, including Highland Park; and WHEREAS, potholes are dangerous for drivers, motorcyclists, bicyclists, and pedestrians; and WHEREAS, potholes have resulted in damage to vehicles, accidents and pedestrian injuries;

WHEREAS, the City Council wishes to provide for the safety and general welfare of its citizens and the public at large; and

WHEREAS, there is an immediate need to fill a significant number of potholes throughout the City; and

NOW THEREFORE, BE IT RESOLVED by Highland Park City Council that DPW be allowed to solicit bids for asphalt to repair the potholes in Highland Park. Yeas (5), Nays (0), Absent (0).

WHEREAS, the City Council wishes to provide for the safety of general welfare of its citizens and the public at large; and

NOW THEREFORE, BE IT RESOLVED by Highland Park City Council that DPW be allowed to solicit quotes for catch basin and curb inlet cleaning.

FINALLY, BE IT RESOLVED that the Director get prices on the repair of the old sweeper if there is one. Yeas (5), Nays (0), Absent (0).
