The following request was submitted from the Fire Chief for approval.

The City of Highland Park has been without a ladder truck since March of this year. For the past 6 months I have searched several states for a truck suitable to our budget and needs. I have

finally located a 2004 Pierce 105 Foot Ladder Truck in Orland Park, Illinois, a suburb of Chicago for \$270,000. The Fenton Fire Equipment Company is the broker. Attached are the specification sheet and invoice.

The insurance reimbursement for the 2000 ladder truck donated in 2013 (which cost \$320,000 is \$110,000. I am asking the Council for a Fire Department budget amendment of \$160,000 and the permission to purchase this truck.

WHEREAS, the City of Highland Park Fire Department is in dire need of a ladder fire truck to replace the ladder truck destroyed by fire on March 8, 2017, resulting in a total loss, and;

WHEREAS, the City of Highland Park and the Highland Park Water Department agrees to Comply with and be bound by the terms of the ACO; and

WHEREAS, the City of Highland Park and the Highland Park Water Department agree in principle with the ACO executed on July 28, 2017, the City of Highland Park will reserve the right for the City of Highland Park to use financial discretion and revise item completion dates based on current pursuit of funding sources, amount of award by those sources, pending financial obligations, and revenue collected for completion of improvements identified in the Significant Deficiency Violation Notice and ACO; and
